

## PRODUCT USE GUIDE FOR EVOLUTION DOUBLE AGENT EV3DA CONCENTRATED SURFACE CLEANER & SANITIZER DA1 (RED) DA2 (BLUE)

### Product Description

A system to reduce the risk of disinfectant resistant bacteria. Double Agent products are supplied in two colour coded formulations. Rotating the two products reduces the risk of bacteria developing resistance to the agents designed to destroy them. For use in hospital wards, nursing homes, catering and kitchen areas and washrooms.

- Conforms to BSEN 1276 and BSEN 13704 and is effective against MRSA, listeria monocytogenes, salmonella typhimurium, pseudomonas aeruginosa, enterococcus hirae, staphylococcus aureus and e.coli at 20°C after 5 minutes contact time, and clostridium difficile after a contact time of 30 minutes.
- It has also been tested under BSEN 1276 and found to kill 99.9% of germs within 30 seconds when diluted 2.7% (20ml in 750ml water).
- Passes BS 5929 (1984) triangle taint test showing it to be non-tainting to foodstuffs and hence safe for use where food is processed.

### Product Features

- Devised to reduce the risk of disinfectant-resistant bacteria.
- For use through the Evolution Dispensing System.
- For all hard surfaces including work surfaces, microwaves, fridges, freezers, chopping boards and tiles.
- Dilutions of this product are extremely stable and will keep for several months without losing their bactericidal activity.
- Regulation (EC) No 396/2005 Maximum Residue Levels. The biocide in this product (Benzalkonium Chloride -red formulation or Didecyl dimethyl ammonium chloride -blue formulation) has an MRL of 0.1ppm. And therefore food preparation surfaces must be rinsed thoroughly with clean water after disinfection.
- The product may be dispensed by the Evolution system into the 750ml flask at a rate of 5ml, 10ml, 15ml or 20ml, depending upon the strength of finished product required. The following dilution rates are recommended :

|      |                         |      |                         |
|------|-------------------------|------|-------------------------|
| 5ml  | Light soiling           | 15ml | Medium to heavy soiling |
| 10ml | Light to medium soiling | 20ml | Heavy soiling           |

### Direction for Use

- Wipe surface area to be cleaned, removing all debris.
- Apply product to paper wipe.
- Wipe surface to be cleaned, paying attention to under edges and corners.
- Repeat steps 2 and 3 for effective surface coverage.
- Rinse well
- Allow to air dry.
- Rotate the products. When one pack is empty, replace with one of the other colour.

# PRODUCT USE GUIDE FOR

## EVOLUTION DOUBLE AGENT EV3DA

### CONCENTRATED SURFACE CLEANER & SANITIZER

#### DA1 (RED) DA2 (BLUE)

#### Refilling 750ml Flask

- Follow bottle filling directions on product system chart. When empty, fill to top line of bottle.

#### Reloading Pouch Pack

- (1) Remove empty pouch from dispenser and dispose of as normal waste.
- (2) Remove screw cap.
- (3) Insert pouch in Evolution Dispenser No. 3.
- (4) Depress locking cap firmly into pouch.
- (5) Lock cabinet.
- (6) Insert over-rider key and pump until product is dispensed (ensure flask is in place).

#### Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children

#### Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.

#### Environmental

- Neat product may cause damage to plant and animal life.
- Do not allow neat product to enter surface waterways.
- In the event of a large spillage, contact the local water authority or Environmental Agency immediately.
- This product uses recyclable packaging. The detergents used in the formulation are biodegradable to EU guidelines under the detergents regulations (EC) No 648/2004.
- It contains no Phosphates.
- None of the components of this product are animal derived.
