

PRODUCT USE GUIDE FOR HEAVY DUTY DEGREASER CBBGS/5

Product Description

A specially formulated food safe heavy duty hard surface cleaner designed for the most arduous of tasks – the cleaning of hard surfaces in a wide variety of industrial environments – including the food processing industry, where its main use is the removal of fatty and protein deposits. Its high alkali levels along with its combination of amphoteric and non-ionic surfactants ensure rapid removal of most types of soiling, including rubber from factory floors. It may be used in both high-pressure washers and steam cleaners.

Caution - This product is not suitable for use on aluminium surfaces.

Direction for Use

- For general cleaning and degreasing:
- Dilute at 1:50 with warm water, wipe over with a brush or a cloth and rinse with cold water.
- Heavy grease & burnt on deposits - soaking: Fill vessel with a 1:25 solution, leave to soak for 30 minutes, then clean in the normal way.
- Heavy grease & burnt on deposits: Use 1:10 or neat depending on the degree of soiling. Wipe over with a brush or a cloth and rinse with cold water. Depending on the surface, it may be necessary to rinse with a mild acidic solution to neutralise residual caustic.
- Safe on stainless steel but will discolour or damage aluminium utensils and surfaces.

Storage

- Store in cool conditions away from direct sources of heat.
- Avoid extremes of temperature.
- Do not allow to freeze.
- Ensure the cap is tightly fitted after use.
- Keep out of reach of children.

Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.

Environmental

- Neat product will cause damage to plant and animal life.
- Do not allow large quantities of neat product to enter surface waterways as serious ecological damage may be caused.
- In the event of a large spillage, contact the local water authority or Environment Agency immediately.
- This product uses recyclable packaging. The detergents used in the formulation are biodegradable to EU guidelines under the detergents regulations (EC) No 648/2004.
- It contains no Phosphates.
- None of the components of this product are animal derived.
