

# PRODUCT USE GUIDE FOR EVOLUTION EV7 CONCENTRATED AIR FRESHENER N1

## Product Description

Formulated to neutralise and deodorise natural body odours and stale tobacco. Leaves rooms with a refreshing pot pourri fragrance.

## Product Features

- Specially designed for use through the Cleenol Evolution dispensing system.
- Neutralises and deodorise natural body odours and stale tobacco. Leaves rooms with a refreshing pot-pourri fragrance that naturally complements the bath and washroom cleaner products in the range.
- The product may be dispensed by the Evolution system into the 750ml flask at a rate of 5ml, 10ml, 15ml or 20ml, depending upon the strength of finished product required. The following dilution rates are recommended :

5ml	Light duty deodorizing	15ml	Medium to heavy duty deodorizing
10ml	Light to medium duty deodorizing	20ml	Heavy duty deodorizing

## Direction for Use

- Spray between 2 – 3 sprays in the centre of the room, avoiding furniture. Best applied to fabrics, curtains and carpets. Always test a small area before general use. Do NOT use in uncarpeted floor areas.

### Refilling 750ml Flask

- Follow bottle filling directions on product system chart. When empty, fill to top line of bottle.

### Reloading Pouch Pack

- (1) Remove empty pouch from dispenser and dispose of as normal waste. (2) Remove screw cap. (3) Insert pouch in Evolution Dispenser No. 7. (4) Depress locking cap firmly into pouch. (5) Lock cabinet. (6) Insert over-rider key and pump until product is dispensed (ensure flask is in place).

## Storage

- Store in cool conditions away from direct sources of heat
- Avoid extremes of temperature
- Do not allow to freeze
- Keep out of reach of children
