### Direction for Use

- Use in the final rinse at the rate of 4-6 ml / kg of dry weight wash load.
- Do not use on kylies. This may be reduced to as low as 2-3 ml when used in conjunction with an agreed Cleenol multi-product laundry dosing programme. Please contact your Cleenol Laundry Specialist for further details.

### Storage

- Store in cool conditions away from direct sources of heat- not suitable for hot climates.
- Avoid extremes of temperature
- Do not allow to freeze
- Ensure the cap is tightly fitted after use
- Keep out of reach of children

### Shelf Life

- Shelf life 24 months, if stored as recommended.
- Use within 6 months of opening.
